Harvest and Reserves

All stands, reserve cedar, white pine, non-merchantable timber, and non-hazardous snags. Tamarack stands, reserve 1 fully crowned tamarack seed tree every 80-100 feet. If there is no tamarack, reserve 1 fully crowned fir or black spruce. Reserve red pine in eastern tamarack stand.

Reserve all timber 50-60 feet from Stowe Lake.

Access

Private road and land must be used to access part of this timber sale. Access road must be kept in good condition at all times. 1/4 mile to County Road 53.

It is the permit holder's responsibility to obtain approval from private landowner before gaining access to the permit area.

Landings and Access Roads

Berm must be installed after sale is completed.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed. Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Cutting, Felling, and Skidding

Do not damage reserve trees.

Painted harvest boundaries have 3 orange dashes, and painted property boundaries have 3 orange circles. Rest are natural boundaries. Red pine stand on the western side, cut 12 foot access strips reserving 40 feet in between strips for thinning. Thin stand down to an average of 90 basal area. Favor the removal of smaller diameter, poor quality, and damaged trees. Utilize trees 2 sticks and larger up to a 3" top.

Slash Disposal

Slash must be evenly distributed throughout permit area.

A 10 foot wide slash free zone must be maintained along County Road 53.

Slash height must not exceed 3 feet within view of County Road 53.

Regeneration Plan

Natural regeneration with tamarack seed trees and possible aerial seed black spruce.


