Cutting, Felling, and Skidding

Ash Thin; Operator Select- Thin stand down to an average of 50 basal area. Favor the removal of smaller diameter, poor quality, and damaged trees.

Ash Thin; All aspen and balm will have 60ft radius gap cuts.

Aspen Clearcut; Harvest all stems except reserve trees.

Do not disturb survey markers, including witness trees.

Sale boundaries painted blue or are natural.

Site, Soil, and Water Protection

Blk 6 has a creek a 50ft buffer has been painted in orange. No clearcutting within the buffer & only one stream crossing.

Slash must be kept out of the creek.

Natural regeneration.


