Harvest Types: Operator select spruce thin, Low hardwood operator select thin, Clear-cut w/reserves, and Low hardwood gap clear-cut.

REOFFER

Harvest and Reserves

White spruce thin: Clear-cut 12 ft. wide strips every 40 ft. and thin in between each strip. Target a residual basal area of 90 sq. ft. Thin from below, favoring the removal of poor form individuals.

Gap Clear-cuts. Harvest all stems within 1/2 acres (166.5 ft diameter) of orange ringed center trees. Skid trail between gaps should not exceed 12 ft. in width.

Unmarked selection thinning: Reduce standing basal area to a target of no less than 60 sq. ft. Focus on the removal of ash species first.

Aspen/Lowland conifer clear-cuts: Harvest all merchantable stems, except for reserve species.

Reserve all oak, birch, and pine species. In addition, reserve snags and cavity trees. Within hardwood thin, reserve advanced regeneration of non-ash species.

Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.

Culvert(s) may be needed on access road(s).

Berm(s) must be installed when hauling and road work is complete. District Forester will determine material, size, and location.

Cutting, Felling, and Skidding

Utilize all merchantable timber felled during road/trail construction.

Timber must be processed at the stump.

Minimize damage to reserve species.

Stump height of all felled timber shall not exceed 3/4 the diameter of the tree.

Do not damage unmarked trees / regeneration / reserve trees.

Site, Soil, and Water Protection

Temporary water/wetland crossing needed on one or more locations. Remove crossing when harvesting activity is completed.

If site/soil damage becomes apparent, alter or cease operations and contact sale administrator immediately.

Roads and skid trails must be stabilized. This may involve slashing, installing water bar, strikeouts, and / or mulching and seeding.

Slash Disposal

Slash must be scattered throughout permit area.

If chipping, 20% of tops and limbs must be scattered throughout the permit area per Site Level Forest Management Guideline. The 20% is in addition to incidental breakage.


