Harvest and Reserves

If summer harvest is pursued operation must process trees at the stump and utilize slash on skid trails. This aims to protect soils from rutting and compactions.

Reserve all non-hazardous snags.

Reserve all pine, yellow birch, basswood, and oak species. Reserve single stemmed, full crowned maple. In addition, reserve all Balsam fir with 2 or fewer sticks.

Access

Private / Easement road must be used to access the timber sale. Access road must be kept in good condition at all times. Federal / State / Private must be crossed to access timber sale. Logger must obtain permits/ permission from land owner/ land manager.

Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator. Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.

Cutting, Felling, and Skidding

Utilize all merchantable timber felled during road/trail construction.

Minimize damage to reserve species.

Do not damage unmarked trees / regeneration / reserve trees.

Do not fell timber into wetlands or across ownership boundaries.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.

If site/soil damage becomes apparent, alter or cease operations and contact sale administrator immediately.

Can cross intermittent creek / drainage in 1 location. All slash must be pulled from the creek and banks rehabilitated upon sale completion.

Roads and skid trails must be stabilized. This may involve slashing, installing water bar, strikeouts, and / or mulching and seeding.

Reserve all non-merchantable timber within 15ft of all wetlands.

Slash Disposal

Slash must be scattered throughout permit area.

Special Conditions

Timber must be removed from site by the end of the same season as harvesting operations. Loads with mixed species will be scaled as the highest value species unless the consumer scales species separately using County approved methods.
