Harvest Type = Hardwood Select Cut. Clearcut with Reserves.

Harvest and Reserves

Reserve throughout entire harvest area: 'R' painted trees, non-hazardous snags, oak, cedar, elm, balsam less than 2 sticks, yellow & paper birch.

N.Hwd Strip Cut - Clearcut 40' strips oriented East-West from forest road on east side of stand. Reserve 40' of timber in between CC strips. Select cut Ash greater than 8" DBH from 40' reserve strip of timber. Within CC strips reserve: hardwood regeneration patches and other species listed for reserve.

Lowland Hwd Select Cut - Select cut Ash greater than 8" DBH. Reserve all other trees unless necessary

Spruce/Tamarack Clearcuts - Clearcut all stems greater than 5' tall.

Aspen Clearcut - Clearcut all stems other than reserve species

Landings and Access Roads

No new roads or landings should be needed, however location and construction of any new roads/landings must be pre-approved by the sale administrator. All of the wood will be landed on the road south of the wooden gate.

Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.

ATV Trail shown on map through Lowland hardwood and Hardwood strip cut areas must be left open. There are short sections of boardwalk on this trail that cannot be damaged or crossed. The entire trail will be flagged heavily prior to harvest and identified at presale meeting.

Cutting, Felling, and Skidding

Do not damage unmarked trees, regeneration, or reserve trees.

Do not fell timber into wetlands or across sale boundaries.

Sale boundaries painted Orange Slashes (III). Natural boundaries shown on map.

Slash Disposal

Slash must be evenly distributed throughout permit area. A 10 ft. wide slash free zone must be maintained along roads and trails. ATV trail must be kept free of slash.

Special Conditions

All Black Spruce stems greater than 5ft. must be severed. Mistle Toe prevention


