Harvest Type = Clearcut. Timber is being cleared for Airport flight lines

Biomass harvesting is optional. The entire sale would then be scaled as mixed biomass.

#### Harvest and Reserves

IMMATURE ASPEN TYPES (Less than 35 years old) +/- 49 Acres, 17 cd/ac, 820 cords, 1,075 Non-Merch Stems/Acre to be felled MATURE ASPEN & NORTHERN HARDWOOD TYPES (40-70 Years old) +/- 44 Acres, 34 cd/ac, 1,500 cords

#### Access

If Hammerlund's haul road west of the airport is used it may need dusk control as determined by Airport Manager. It is the Permit Holder's responsibility to cover the costs of dust control.

0.3 miles to public road (Harris Town Road) through B&L Properties, Inc. (Private Access)

Access road from the south (Harris Town Road) is through B&L Properties, Inc. It is the Permit Holder's responsibility to acquire an access agreement.

All wood must be hauled and road repairs completed by October 15.

2 miles to public road (Airport Road) through Airport using Hammerlund's haul road (Public Access)

#### Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator. Landings must be located off on existing road (snowmobile trail).

Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned. Road rehab must be completed by October 15.

#### Cutting, Felling, and Skidding

All stems throughout the entire sale area must be Clearcut

Some steep slopes occur on this permit, which may require hand felling.

Do not disturb survey markers, including witness trees.

Sale boundaries painted with Orange Slashes (III). Property boundaries painted with Orange Circle (oOo). Natural Boundaries shown on map.

#### Site, Soil, and Water Protection

Roads and skid trails must be stablized. This may involve installing water bars, strike outs, and/or mulching and seeding. Any rutting that occurs must be rehabilitated as directed by sale administrator.

Slash Disposal

Slash must be evenly distributed throughout permit area. NO PILING. All slash must be back hauled and end piles leveled out.

A 10 ft. wide slash free zone must be maintained along roads and trails.

Slash height must not exceed 3 ft. within view of road/snowmobile trail.

### Special Conditions

Utilize all trees with at least 2 sticks up to a 4" top.
