Clearcut 45 acres of aspen, 17 acres of jack pine, and 5 acres of red pine.

Harvest and Reserves

Reserve all white pine, oak, and non-hazardous snags. In aspen stands west of Co. Rd. 7 reserve all red pine, non-merchantable conifers, and 2 large birch or aspen/acre. Also reserve all trees inside of the pink flagging around the dump buildings.

Access

Easement roads must be used to access the timber sale. Access road must be kept in good condition at all times.

Gate into the dump must be locked at all times, except on days when 3 or more loads are hauled. All logging activities around the dump and hauling through the dump must be done when the dump is closed. Summer dump hours are 8:30 am - 4:30 pm on Monday and Thursday through Saturday.

ATV trail regulations in Itasca County Forest Management Guideline & Specifications apply.

Landings and Access Roads

Within 15' of Co. Rd. 7 reserve all maple, red pine <10", and non-merchantable timber.

Berms must be installed after sale is completed.

Landings must be kept back at least 100' from Co. Rd. 7.

Cutting, Felling, and Skidding

Do not damage reserve trees.

Sale boundaries are painted in blue or are natural boundaries.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50'-70' of all wetlands depending on slope.

Reserve all non-merchantable timber within 15ft of all wetlands.

Slash Disposal

In the southeast part of the sale 70% of the slash(all of the red pine tops) must be pile at designated areas determined by the forester. 30% of the slash must be scattered across the site including 2-12" by at least 6' logs with bark on. The remainder of the sale the slash must be evenly distributed throughout the sale area.

A 10 ft. wide slash free zone must be maintained along roads and trails.

Slash height must not exceed 3 ft. within view of Co. Rd. 7.

Regeneration Plan

Aspen types west of Co. Rd. 7 will be naturally regenerated to aspen. The northeast part of the timber sale will be planted to jack pine and the southeast area will be planted to red pine.


