Reserve oak, 1 fully crowned white pine at least 10-14" in diameter every 100', and non-hazardous snags.

#### Access

Cabin lease road must be used to access part of the timber sale. Access road must be kept in good condition at all times. The pipe leading to the septic is under this road. Matting must be laid on road above pipe to protect it from heavy traffic.

Snowmobile trail regulations in Itasca County Forest Management Guideline & Specifications apply. A minimum of two inches of compacted snow must remain on the trail as a running surface.

#### Landings and Access Roads

Reserve all red and white pine < 10" and non-merchantable timber within 15ft of all roads.

Landings must be kept back at least 100' from Co. Rd. 52.

### Cutting, Felling, and Skidding

Do not damage reserve trees.

Do not disturb survey markers, including witness trees.

Sale boundaries are painted in blue or are natural boundaries.

#### Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 70' of all wetlands.

Reserve all non-merchantable timber within 15ft of all wetlands.

#### Slash Disposal

Slash is to be piled at administrator approved locations. 20% of tops and limbs must be scattered throughout the permit area per Site Level Forest Management Guideline. The 20% is in addition to incidental breakage.

A 20 ft. wide slash free zone must be maintained along Co. Rd. 52 and 10ft. along all other roads and trails.

### **Regeneration Plan**

All of these stands will be planted to red pine.


