#### Harvest and Reserves

Comments

In the clearcut area, reserve all oak, one 10" or bigger fully crowned white pine every 100', and all non-hazardous snags.

#### Access

Private road must be used to access the timber sale. Access road must be kept in good condition at all times.

.5 miles to Co. Rd 53.

#### Landings and Access Roads

2-culverts may be needed to access the northwest parts of this timber sale. Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

## Cutting, Felling, and Skidding

Full tree/whole tree skidding required across the clearcut area. 30% of the tops and slash must remain across the site.

Do not damage reserve trees.

There is 6 acres of 1st time red pine thinning on the northwest block. Cut 12 ft. access strips reserving 40 ft. in between strips for thinning. Thin stand down to an average of 80 basal area. Favor the removal of other species, smaller diameter, poor quality, and damaged trees. There is 1 acre of marked red pine thinning in the northeast block. Cut only trees marked with orange paint. Sale boundaries painted blue or are natural boundaries.

#### Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 60' of all wetlands.

Roads and skid trails must be stablized. This may involve installing water bars, strike outs, and/or mulching and seeding.

Reserve all non-merchantable timber within 15ft of all wetlands.

#### **Regeneration Plan**

The clearcut area will be planted to red pine.
