Comments

Reserve all oak, basswood, pine, spruce, birch < 3 sticks, non-merchantable balsam, and non-hazardous snags.

### Access

5.7 miles to Co. Rd. 49 or 4.8 miles to Co. Rd. 339.

There are 2 easement roads that may must be used to access the timber sale. These roads must be kept in good condition at all times.

## Landings and Access Roads

Reserve all non-merchantable timber within 15ft of the Lum Lake road.

Logger cannot land wood on the gated road on the north edge of the timber sale. The gravel pit is available to land on.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

## Cutting, Felling, and Skidding




