Harvest Specifications

Harvest Type

Northern hardwood clearcuts w/reserves (51 acres), First time white spruce thins (23 acres,operator select), Ash thins (4 acres,operator select) Re-Offer

Reserve Guidelines

On the large part of the northern hardwood type to the north, reserve pine, cedar, snag and cavity trees, any trees painted with orange (some birch and oak seed trees), and unmarked aspen. Harvest any blue painted oak and aspen. Do not damage reserve trees. On the smaller northern hardwood stand to south, follow same reserve requirements except harvest all of the unpainted aspen.

Cutting, Felling, and Skidding

On first time white spruce thins, trees must be processed at the stump. Clearcut 12' strips reserving 40 ft. in between strips for thinning. Favor the removal of smaller diameter, poor quality and damaged trees.Remove competing species (pine, balsam, aspen) first, leaving the best white spruce crop trees. Thin to 90BA (operator select).

On ash thin areas shown on map, thin stands to 1/2 their basal area by removing the larger daimeter trees (operator select).

Most of sale boundaries are painted orange.

Access

Private road portion (see map) must be used to access the timber sale. Access road must be kept in good condition at all times.

Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

Site, Soil, and Water Protection

Filter strip is required with <5% soil disturbance within 50' of intermittant creek.

Slash Disposal

Slash must be evenly distributed throughout permit area.

A 10 ft. wide slash free zone must be maintained along roads and trails.


