Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.

Cutting, Felling, and Skidding

Timber must be processed at the stump, do not damage reserve trees.

Follow the existing cutout strips from earlier thin in 2004 and thin between the strips down to an average of 90 basal area. Favor the removal of smaller diameter, poor quality, and damaged trees.

Sale boundaries painted orange.

Slash Disposal

Slash must be evenly distributed throughout permit area. Maintain a 10' wide slash free zone along roads.

Special Conditions

Logging season may be restricted till August during high bark beetle risk. All cut pine must be hauled within 3 weeks during May through September.
