Harvest type: Aspen Clearcut W/Reserves (31.2 AC) and a 1st time Red Pine Thin(17.6 AC)			

### Harvest and Reserves

Aspen Stand: Harvest Aspen, Balsam Fir, Spruce, Paper Birch, and any marked hardwoods. Reserve Oak, Pine, Maple, Ash and Basswood Red Pine Thin: Thin Red Pine from 150 Basal area to 90. First cut 12 Ft access strips reserving 40 FT in between strips. Then thin from below between the strips favoring the removal of smaller diameter, poor quality and damaged stems; Reserve all other species unless overtopping crop tree.

Reserve all non-hazardous snags.

Access

Access is across Itasca County Tax Forfeit Land.

Water bars will need to be put in place on parts of the road within 2 weeks of the timber being removed.

#### Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.

Culvert(s) may be needed on access road(s).

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

#### Cutting, Felling, and Skidding

Within the Red Pine Stand Timber must be processed at the stump.

Do not damage reserve trees.

Do not fell timber into wetlands or across sale boundaries.

Some steep slopes occur on this permit, which may require hand felling.

Sale property boundaries painted With Orange circles.

Sale cutting boundaries are painted with Orange slashes.

#### Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.

Roads and skid trails must be stablized. This may involve installing water bars, strike outs, and/or mulching and seeding.

Reserve all non-merchantable timber within 15ft of all wetlands.

#### **Special Conditions**

Logging season may be restricted to August through February during high bark beetle risk. All cut pine must be hauled within 3 weeks during June through August.

#### **Regeneration Plan**


Within the Aspen Type we will have natural regeneration of aspen, birch, maple, spruce and balsam fir.

Within Red Pine Stand:Due to nature of managed species and type of harvest little to no tree regeneration is expected to occur after harvest.
