Thinning Block-Cut all aspen, balm, paper birch, ash >8 inches and all marked maple and basswood

Overstory Removal Block- Harvest all species on contract

Thinning Block -Reserve yellow birch, pine, oak, balsam fir, spruce, cedar, unmarked maple, basswood and all advanced regen

Overstory Removal Block - Reserve all species not on the contract and all advanced regen.

Reserve all non-hazardous snags.

A resonable effert should be made to cut all Ironwood >2 inches in diameter

Access


