Spruce clearcut w/reserves:

Cut all stems within spruce clearcut w/reserves area, unless they meet reserve species specifications.

Reserve all species besides aspen, spruce, and tamarack within spruce clearcut area.

Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator.

Trails and landings need to be rehabilitated to a satisfactory condition before performance bond is returned.

Berm(s) must be installed after sale is completed.


