Comments

Reserve all non-hazardous snags - except tamarack snags. Cut all dead/dying tamarack due to pockets of bark beetle infestation. Clearcut all merchantable aspen, tamarack, black spruce, paper birch, balsam fir, ash and red maple. Do not cut any other tree species or trees painted with an orange "R". In the tamarack stand, reserve 12 healthy, fully crowned tamarack seed trees over 5 inches in DBH every acre. Space seed trees 60 feet apart.

#### Landings and Access Roads

Location and construction of any new roads/landings must be pre-approved by the sale administrator. Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Roads and landings must be approved by sale administrator.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

#### Cutting, Felling, and Skidding

Do not damage reserve trees marked with an orange "R".

Sale boundaries painted Orange Slashes (III) are shown on map. All other boundaries are Natural. Trees ending each painted line have the word "END" written on them including 3 dashes as well as a pink ribbon. On the sale's southeast corner, an orange boundary line is painted with 3 HORIZONTAL dashes and "B1" written on each tree. "B1" stands for boundary one. This line separates this sale from an adjacent sale 120 feet to the east of it (i.e. 429 East Sale). In addition, trees that end this line have the word "END" written on them as well as a pink ribbon.

Slash Disposal

Slash must be evenly distributed throughout permit area.


### **Regeneration Plan**
