Harvest and Reserves

Reserve: Y.Birch, Basswood, Cedar, Elm, Balsam Fir < 2 sticks, & all non-hazardous snags.

Reserve trees marked with "R" or Blue Ring.

Ash Thin: Retain 50 Basal Area Ash & reserve species. Select largest diameter Ash for removal 1st. Harvest no more than 50% of the Basal Area. In SE Ash block cut all Balm/Aspen.

Reserve all non-hazardous snags.

Located on CR 67 and CR 68 (Splithand Rd). Accesses off either road may be used.

Landings and Access Roads

Trails and landings need to be rehabilitated to a satisfactory condition, determined by administering forester, before performance bond is returned.

Berm must be installed where designated at access off CR 67 after sale is completed.

Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

Cutting, Felling, and Skidding

21.9 acres Dry Summer Chance if timber is processed at the stump - see map

Do not damage reserve trees.

Do not fell timber into wetlands or across sale boundaries.

Do not disturb survey marker, including witness trees; shown on map at SE corner of sale.

Sale boundaries painted Orange Slashes (III). Property boundaries painted Orange Circle (oOo). Natural boundary against aspen sapling type shown on map.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.

Slash Disposal

Slash must be evenly distributed throughout permit area.

A 10 ft. wide slash free zone must be maintained along roads and trails.

Slash height must not exceed 3 ft. within view of road.


