Harvest and Reserves

Reserve all oak, basswood, ash, conifers(except in the black spruce type), non-merchantable maple, birch < 8", and non-hazardous snags. Within 100' of driveway and garage also reserve all birch, maple, and non-merchantable timber.

Landings and Access Roads

Reserve all hardwood and non-merchantable timber within 15ft of Co. Rd 51.

Berm must be installed after sale is completed.

Landings must be kept back at least 100' from Co. Rd. 51.

Cutting, Felling, and Skidding

Do not damage reserve trees.

Do not disturb survey markers, including witness trees.

Sale boundaries are painted in blue or are natural boundaries.

Site, Soil, and Water Protection

Filter strips require <5% soil disturbance within 50' of all wetlands.


