Reserve all non-hazardous snags, white pine, cedar and unmerchantable balsam along road. Additional visual screening considerations will be applied along the county road corridor.

#### Access

Access off of County road 22.

#### Landings and Access Roads

Roads and landings must be approved by sale administrator. Trails and landings need to be rehabilitated to a satisfactory condition determined by administering forester before performance bond is returned. Timber sale administrator shall be notified at least 3 working days prior to completion of hauling and road work. This provides adequate time for permit area inspection and addressing of permit compliance requirements before hauling and road work equipment is removed.

#### Cutting, Felling, and Skidding

Sale boundaries painted orange. Cutting may be done with conventional or a cut to length harvesting system, do not damage reserve trees.

Filter strips require <5% soil disturbance within 50' of all wetlands, do not fell timber into intermittent stream.

Slash must be evenly distributed throughout permit area. Keep all slash 25' away from road and maintain a slash height less than 3' in view of road.


#### **Regeneration Plan**
